- ✓ Signed Proof of Submission Form (18AB042)
- ✓ Signed Owner Agent Designation Form (if applicable) (AB043)
- ✓ Full payment for requested services, as indicated above

Note: Full payment of plan review, inspection and travel fees is required prior to services being rendered.
